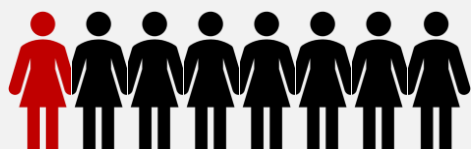


The National Center for Missing and Exploited Children reports that

The Demand Project exists to eradicate human trafficking, online enticement, child abuse imagery, and the commercial sexual exploitation of children.

Our strategy is

- **Prevention** of victimization through awareness and education
- **Prosecution** of sexual predators through cyber investigation and support for law enforcement operations
- **Rescuing** victims of sexual exploitation by collaborating with law enforcement and VAS Teams
- **Restoration** by empowering survivors to choose their own Journey to Freedom through nonresidential and residential Journey Program

PREVENTION

The Demand Project believes in educating, equipping, and empowering the community on how to stay safe against child predators who seek to harm children.

PROSECUTION

The Demand Project believes that law enforcement plays a key role in stopping child predators, protecting children, and rescuing victims.

RESCUE

The Demand Project believes there is a place for Non-Governmental Organizations (NGO's) to be of assistance to law enforcement in the rescue of sexually exploited victims. This can only happen with a collateral partnership between both organizations.

RESTORATION

The Demand Project believes that rescuing a victim from sexual exploitation is only the beginning of an extensive process for a victim to become a survivor.

The Journey Program Journey Teams are committed to equipping each resident with the necessary tools to find her individual pathway to healing and to choose her own Journey to Freedom.

About Mount Arukah

The Mount Arukah campus will provide up to 60 beds for underage female survivors, making it one of the largest housing options for survivors of sex trafficking and sexual exploitation in the United States. The Journey Program is a victim-centered, community-driven, trauma-informed approach to restoring a survivor's life. Each resident's Journey Team consists of a house guardian, mentor, case manager, resource link, life skills coach, peer support specialist, and therapist. The team addresses six areas: mental health, physical wellness, spiritual wholeness, financial peace, education and employment, and legal matters affecting a survivor's restoration.

Nonresidential Program

The Demand Project has been offering nonresidential survivor services since 2013 and will continue to provide these services for adult clients, both men and women, and male minors.
